ASSETS AND LIABILITIES:-

Regarding assets and liabilities of the two individual associations which are menging together in the from of the newly formed "Georgian Alumni Association", it is agreed that all the assets of the enstwhile Alumni Association, IC. G. Medical College (originally know as "Old Boys Association" K. G. Medical College) shall be transferred to this newly formed Association, perticularly the building and guest house along with its fixtures, furnishings and furniture etc. It is to be put on record that this Alumni Building situated at the back of the Anatomy Dept. KGMU was constructed in 1930 by the funds provided totally by the them Old Boys Association, KGMC, out of the funds contributed by its members. This Old Boys Association was established under Lucknow University Act and duty confirmed by the then Executive Committee of the Lucknow University. Similarly all the assets of the International Georgian Association shall be transferred to this new Association, liabilities, if any, of these two organizations (Alumni Association, KGMC and International Georgian Association) shall be borne by themselves, and the new Association will have nothing to do with their liabilities if any.
