1. According to provisions of Section2(10) of the University Act " Registered graduate" means a graduate of the university registered in accordance with the statutes and includes a graduate who has acquired a medical degree as a student of the King George's Medical College before the appointed date.
2. Graduate applying for registration of their names are requested to inform the Registrar from time to time change in their permanent address or in occupation.

Rules for the Regulations of Graduates in the K.G's Medical University, Lucknow.

- Statute 4.05 Every graduate of the University from the date of the convocation at which the degree by virtue of which he is to be registered was conferred on him if he was present there at shall, on an application in the form approved by the Executive Council and on payment of fee of Rupees five hundred be entitled to have his name registered in the Register. The application shall be made by the Graduate himself and may either be delivered to the Registrar personally or sent by registered post. If two or more applications are received in the same cover, they shall be rejected.
- Statute 4.06 On receipt of an application, the Registrar shall, if he finds that the Graduate is dully qualified and the prescribed fee has been paid, enter the name of the applicant in the Register.
- Statute 4.07 A Registered Graduate whose name has been borne on the Register for one year or more on June 30 preceding the date of notification for the election shall be entitled to vote at the election of the representatives of Registered Graduates.
- Statute 4.08 A Registered Graduate shall be eligible to seek election under class (ix) of Section 26(1) of his name has been borne on the Register for at least three years on June 30, preceding the date of election.
- Statute 4.09 A representative of Registered Graduate elected under class (xi) of sub section (1) of section 26 shall cease to be a member on entering the service of the University or of an Institute or constituent college, an associated college, a hostel a hall or being connected with the management of an associated college, a hall or hostel or on becoming a students, and the seat so vacated shall be filled up by the person available who secured the next highest votes at the time of the pervious election for the residue of his term.
- Statute 4.10 A Registered Graduate, who is already a member of the Court in another capacity, may seek election as a representative of Registered Graduate, and on his being so elected, the provisions of Statue 4.09 shall mutatis mutandis apply.

Registered Graduate of the University are entitled to elect from own body fifteen members to the court of the University under section 26(1) (ix) of the King George's Medical University Act 2003 as amended and Statutes 4.05 KGMU, Lucknow.
