Memorandum of Understanding

King George Medical University, Lucknow, UP. India and the


R.M.I.T University, Melbourne, Australia

Vice Chancellor of King George Medical University, Lucknow, UP, India , Prof Devendra K Gupta and the Pro Vice Chancellor of RMIT, Melbourne, Australia, Prof Peter Coloe have decided to enter in an agreement . The agreement is aimed to initiate co-operation and contribution to the field of medical science and development of education between the two universities (referred herein as parties). The parties have agreed that ;

1. On the basis of common interest, agree to promote bilateral co-operation in scientific research and education involving;
 - a. Teaching and exchange of scientific researchers
 - b. Development of projects of common interest
 - c. Scientific and educational exchange on the basis of common interest
 - d. Organizing lectures, seminars and scientific meetings
2. Apart from this MOU, future areas of co-operation and the result specifications can be defined in addition to agreement with applicable rules which must be agreed to in working by both the parties.
3. Both institutions would work jointly in projects of mutual interest, taking in to consideration work involving other institutions and international projects.
4. The institutions would explore ways and means to finance joint projects through special Government and other funding sources. This MOU is not intended and shall not be interpreted, to any kind or form of financial support or consideration.
5. The contract is made in English Language in two copies with equal legal force, one copy for each party. The MOU shall enter into force after being signed by both the parties, and will be reviewed after every 5 years.
