An emergent meeting of the Executive Council of King George's Medical University, Lucknow was held on 20th November, 2025 in the Board Room of Administrative Block, KGMU, Lucknow at 2.00 P.M.

Dr. Uday Bhan Singh, Dr. Surya Kant. Dr. K. K. Singh & Dr. Birendra Kumar Raw joined the meeting through video conferencing.

Deliberations of the meeting and decisions taken were as under:

1.	<p>Compliance with the order of the Hon'ble High Court dated 02.09.2024 in Writ Petition-A No. 5983 of 2024: <i>Shri Akhilesh Kumar Tripathi & 3 others vs. King George's Medical University, Lucknow</i></p> <p>Executive Council was informed that non-teaching employees of King George's Medical University, Lucknow were granted parity with the non-teaching employees of SGPGIMS, Lucknow vide U.P. Government Order No. 3288/71-2-16-RM-18/2014, dated 23.08.2016. In continuation of the said order, the Government of Uttar Pradesh issued a cadre restructuring order for <i>Medical Social Worker/Social Worker on dated 07 April-2017</i> in accordance with the existing cadre structure of SGPGIMS vide order dated 21.09.2016.</p>	<p>Executive Council deliberated on the matter at length and after due deliberation decided as under:</p> <p>(a) The benefit of cadre structuring of the Social Worker's cadre be granted w.e.f. 21.09.2016 as provided in the Government order dated 07.04.2017.</p> <p>(b) The benefit of ACPS be granted to the eligible employees as per guidelines existing at SGPGIMS, Lucknow.</p> <p>(c) The existing committee for grant of ACPS should review the individual matter of applicants for grant of ACPS and submit its report within one week. The recommendation of the ACPS committee be placed before the</p>

In compliance with the above order, the applicants were adjusted in the revised structure vide University Order No. **808/Non-Teaching Establishment/2017**, dated **15.09.2017**.

Subsequently, Shri Akhilesh Kumar Tripathi and certain other employees of the cadre submitted an application dated **01.08.2022** to the Registrar, alleging inappropriate pay fixation and requesting grant of cadre-restructuring benefits from the date of issuance of the Government Order.

Finance Officer was requested to furnish his comments. The Finance Officer submitted the following observations:-

“उक्त संवर्ग के कर्मचारियों की नियुक्ति पूर्व में ग्रेड पे-4600/- (ग्रेड पे 2800/- से ग्रेड पे 4600/- में उच्चिकृत) में किया गया था। उक्त के अनुसार प्रथम ए0सी0पी0 10 वर्ष पर ग्रेड पे0-4800 /- द्वितीय ए0सी0पी0 20 वर्ष पर ग्रेड पे0-5400/- एवं तृतीय ए0सी0पी0 30 वर्ष पर ग्रेड-6600/- की देयता बनती है। चूंकि 10 वर्ष पूर्ण होने के पूर्व ही सुपरवाइजिंग मेडिकल सोशल ऑफिसर को ग्रेड पे-5400/- का लाभ एस0जी0पी0जी0आई0 के समान पदस्थापित किया गया। अतः प्रथम ए0सी0पी0 की देयता नहीं बनती है।

दिनांक: 15.09.2017 से सुपरवाइजिंग मेडिकल सोशल सर्विस आफिसर के पद पर पदस्थापित किया गया है। पदस्थापित के पश्चात् नियम 22ए में दिये गये नियम के अनुसार वेतन निर्धारण का लाभ दिया गया है उक्त नियम के अनुसार किसी प्रकार के वेतन वृद्धि का लाभ दिया जाना उचित नहीं है।”

The above opinion of the Finance Officer was communicated to the applicants vide Registrar Letter No. **2643/Non-Teaching Establishment & Pension Section/24**, dated **26.06.2024**. Aggrieved, from the decision of the University, Shri Akhilesh

Executive Council for deliberations and decision so that compliance report may be submitted in the Hon'ble High Court accordingly within time limit.

(d) It was also decided that in case any other matter of Non-Teaching Employees for granting the benefit of G.O. dated 23.08.2016 is pending the same will be decided on priority in a time bound manner.

Kumar Tripathi & 3 others filed **Writ Petition–A No. 5983 of 2024**, seeking to set aside the Registrar's order dated 26.06.2024. The Hon'ble High Court passed the following order on **02.09.2024**:

“In view of aforesaid, the impugned order dated: 26 June-2024 is hereby quashed by issuance of writ in the nature of certiorari granting liberty to the executive Council or any other authority competent as per directions of the Executive Council in consonance with 1st Statutes of University to decide petitioners, representation dated: 09th May, 2024 within a period of six weeks from the date of a certified copy of this order is produced before the concerned authority.”

In compliance with the above direction, Shri Akhilesh Kumar Tripathi and others submitted a representation to the Hon'ble Vice Chancellor requesting:

- (a) **To grant of service benefits as applicable in SGPGI, w.e.f. 21.09.2016, including**
- (b) **Grant the benefit of ACP after completion of 10 years of service, and**
- (c) **Fixation of pay accordingly.**

Since the matter involved financial implications, it was again referred to the Finance Officer for his opinion. The Finance Officer submitted the following opinion:-

“चूकि पूर्व मे उक्त कार्मिको का पदस्थापन/समायोजन दिनांक 15.09.2017 से किया गया है, जिसे शासनादेश में वर्णित व्यवस्थानुसार दिनांक 21.09.2016 से संशोधित करते हुए लाभ प्रदान किया जाना प्रस्तावित है, साथ ही उपरोक्त कार्मिकों के पदस्थापन की प्रक्रिया को पदोन्नति मानते हुए एक अतिरिक्त वेतन वृद्धि का लाभ प्रदान किये जाने के सम्बन्ध में शासनादेशों में कोई व्यवस्था उपलब्ध न होने के कारण शासन से अभिमत प्राप्त होने के उपरान्त लाभ प्रदान किया जाना उचित होगा।

शासनादेश दिनांक 07 अप्रैल, 2017 के क्रम में सम्बन्धित कार्मिकों का संवर्गीय पुर्नगठन करते हुए पदोन्नतियों प्रदान की गयी है तथा

दो कार्मिकों यथा श्रीमती शशिबाला एवं श्री अखिलेश कुमार त्रिपाठी की पदोन्नति संवर्ग में प्राप्त पदों की (Hierarchy) अनुसार संवर्ग के चौथे पद चीफ मेडिकल सोशल सर्विस आफिसर पीबी-3 वेतन मैट्रिक्स रू0 67700-208700, लेवल-11 में की जा चुकी है। अतः ऐसी स्थिति में एम0ए0सी0पी0 का लाभ अनुमन्य नहीं है।”

अतः उक्त कार्मिकों को शासनादेश संख्या 1084/71-2-17-के0जी0एन0यू0-67/2013 दिनांक 07 अप्रैल 2017 में निहित व्यवस्था के अनुसार दिनांक 21 सितम्बर 2016 से संवर्गीय पुर्नगठन का लाभ प्रदान किये जाने हेतु मा0 कार्यपरिषद का अनुमोदन प्राप्त करने के साथ-साथ पदस्थापन की तिथि को पदोन्नति मानते हुए 01 अतिरिक्त वेतन वृद्धि का लाभ प्रदान किये जाने के सम्बन्ध में शासन का अभिमत प्राप्त करने हेतु प्रस्ताव मा0 कार्यपरिषद के समक्ष प्रस्तुत करने की अनुमति प्रदान करने का कष्ट करें।”

Based on the above comments and in compliance with the High Court's directions, the Hon'ble Vice Chancellor disposed of the matter by issuing Order No. KGMU/VC/04/2025, dated:- 09 September-2025. the operative portion of which is as follows:-

“अधोहस्ताक्षरी द्वारा उपरोक्त वर्णित तथ्यों एवं वित्त अधिकारी के अभिमत दिनांक 04.09.2025 को संज्ञान लेते हुए शासनादेश संख्या 1084/71-2-17-के0जी0एन0यू0-67/2013 दिनांक 07 अप्रैल 2017 में निहित व्यवस्था के अनुसार दिनांक 21 सितम्बर 2016 से संवर्गीय पुर्नगठन का लाभ प्रदान किये जाने हेतु मा0 कार्यपरिषद का अनुमोदन प्राप्त करने के साथ-साथ पदस्थापन की तिथि को पदोन्नति मानते हुए 01 अतिरिक्त वेतन वृद्धि का लाभ प्रदान किये जाने के सम्बन्ध में शासन का अभिमत प्राप्त करने हेतु प्रस्ताव मा0 कार्यपरिषद के समक्ष प्रस्तुत करने की अनुमति प्रदान की जाती है।”

Meanwhile, Shri Akhilesh Kumar Tripathi filed **Contempt Application No. 2932 of 2025** before the Hon'ble High Court and Hon'ble High Court passed directive to file compliance affidavit failing which the respondents shall appear before this Court in person. List this case in the week commencing 01.12.2025.

During deliberations the Executive Council was informed that the cadre structuring has been approved by the Government of U.P. on the basis of existing cadre structure of Social Worker's at SGPGIMS, Lucknow. SGPGIMS, Lucknow has laid down the guidelines for adoption of ACPS to
