We, accordingly allow the appeal, set aside the impugned order of the High Court and remand the matter to the High Court for decision afresh after the decision of the high Court in the Writ Petition No. 869 (SB) of 2002.</p> <p>Case:- Service Bench No. 612 of 2002.
