2. **Agenda 2: To decide the conduct of Clinical/Practical summative examination of MBBS program**

Professor Amita Jain, Dean Academics, emphasized that the University should strictly adhere to the NMC guideline. After deliberation it was resolved that not more than 50 students should be examined in one day, therefore the practical exams should be conducted in 5 days, in MBBS batch of 250 students. Any additional supplementary students may be allowed on the fifth day of the exam.

3. **Agenda 3: To approve the new pattern of paper for MBBS, BDS examination.**

Controller of Examination brought into the notice of committee that there are regular complaints of cheating of specially MCQ questions from the invigilators. To check this, new pattern of question paper for MBBS and BDS was proposed by CoE, in which each paper will have 3 sections; Section A of MCQs, Section B and Section C of subjective questions. The answer sheets of all the three sections to be distributed at the commencement of the exam and answer sheet of Section A to be submitted after 30 minutes.

The proposal was approved and it was suggested that in future Office of the CoE may work on the feasibility and expenditure of MCQ to be evaluated by OMR reader.

4. **Agenda 4: To decide the guidelines for the evaluation of Answer Sheets of summative examination of MBBS, MD/MS and DM/MCh courses conducted in the University.**

To bring the uniformity in the valuation pattern of answer sheets of summative examination of MBBS program, it was decided after thorough discussion that In MBBS examination, questions of Paper 1 will be distributed among external examiners and of Paper 2 among internal examiners as per decision of senior most internal examiner for valuation. The examiners will check the allotted question in the answer sheet of all the students, and sign against the marks given by them, on the first page of answer sheet. The senior most internal examiner will ensure that the totaling and of marks in both the answer sheets is done and signed by one of the examiner.

For MS/MD/DM/MCh course, it was approved that the answer sheets will be evaluated as per the guidelines issued by the NMC in PGMER 2023.

For digital valuation of the answer sheets of MS/MD/DM/MCh, as proposed by NMC, it was decided that the process of procurement of software should be started from the office of CoE.

It was proposed by the Hon'ble Vice Chancellor that the remuneration for valuation of answer sheets of MS/MD/DM/MCh course should be increased from Rs 25 per copy to Rs 100 per copy with minimum of Rs 1000. It was unanimously approved.

To meet the expenses of digital valuation and double/triple valuation of answer sheets as per instruction of NMC, the Finance Officer suggested that the examination fee of MD/MS/DM/MCh candidates may be increased from the present Rs 20,000 to Rs 30,000. It was approved.

5. **Agenda 5: To decide the time line of Scrutiny for MBBS and other courses run by the University and remuneration for the faculty members of scrutiny team.**

The Controller of Examination brought into the notice of the committee that according to the NMC guidelines, now the supplementary examination has to be conducted and the result of the same should be published within 3-6 weeks of declaration of the result of main examination. Therefore, the present scrutiny guidelines should be modified. After a detailed discussion it was decided that the students can apply for scrutiny within three working days of declaration of result after payment of prescribed fee and the result should be announced within four working days after the last date of invitation for application.

It was also resolved that the faculty members involved in the scrutiny shall be given remuneration of Rs 1000 only for each Professional/Supplementary examination.

6. **Agenda 6: To decide regarding publishing the detailed result online within stipulated time.**
Honorable Vice Chancellor has given permission to publish the notification and detailed result online by the signature of Controller of Examination. The result will be signed by the Honorable Vice Chancellor and be filed.

7. **Agenda 7: To approve the changes done in the past few years, in the time schedule of regular and supplementary examinations of MBBS course according to the guidelines of NMC after taking permission from the Hon'ble Vice Chancellor.**

It was approved unanimously.

8. **Agenda 8: To approve the changes implemented in MBBS examination after issue of clarification in regard to "Competency Based Medical Curriculum" (CBME) Regulations, 2023 via letter N-U015(29)/4/2024-UGMEB-NMC 2024, dated January 5th, 2024:**

- Passing criteria of 50% aggregate in theory and practical, (and minimum 40% in each, to achieve aggregate 50%).
- There shall be no grace marks to be considered for passing in an examination
- Supplementary examinations and declaration of results shall be processed within 3-6 weeks from the date of declaration of the results of the main examination for every professional year
- Internal Assessment will not be counted as separate head of passing for University Examination. However, the student has to be declared as eligible to appear for the University Examination based on the Internal Assessment made by the college authorities
- External examiner may be from outside the college/ university/ state/ union territory.
- The Examiners for General Surgery and allied subjects as well as for General Medicine and allied subjects, shall be from General Surgery and General Medicine respectively

It was approved unanimously.

9. **Agenda 9: To decide the eligibility of non-medical faculty members to be appointed as examiner**

Regarding the eligibility of non-medical faculty to be appointed as examiners, it was decided that clarification should be asked from NMC regarding this matter from Dean office.

10. **Agenda 10: To approve the implementation of new guidelines of INC for Nursing semester wise course.**

It was approved unanimously.

11. **Agenda 11: To approve that the External Examiners, appointed for taking Practical / Viva voce Examinations of BSc (Semester wise) / MSc Nursing course will also evaluate the Answer Sheets of Theory, as it is being done in other courses run by the University.**

It was approved unanimously.

12. **Agenda 12: To approve the answer sheet evaluation pattern for BSc Nursing year wise course.**

It was decided that the answer sheets of parts to be checked by internal and external examiners of BSc Nursing year wise course of Nursing College of KGMU and all the affiliated colleges will be bundled in sets of almost equal number. The internal and external examiners, appointed to take practical examination at College of Nursing of KGMU will check the bundle given to them as per the part allotted. For the rest of the bundles, examiners will be called from the list of approved examiners. It will be ensured that not more than 30-35 copies are evaluated by the examiners per day who are also taking practical examination at KGMU.

13. **Agenda 13: To establish a policy for appointment of a writer for students unable to write their theory examination papers due to medical reason for BDS/Nursing/MD/MS/MDS/DM/MCh courses as it is there for MBBS course.**

It was resolved that for undergraduate courses same policy will be followed as laid down for MBBS course. For first year students another first-year student from across the faculties may be allowed to write the exam. For postgraduate courses the writer may be appointed from undergraduate courses from the year/semester who has not started studying the same subject.

14. **Agenda 14: To revise the refund policy of the Examination Fee.**

It was resolved that the students who are declared ineligible to appear in the examination and if they have already submitted their examination fees, the fees will be refunded or adjusted in the upcoming examination. Remaining clause of exam fee refund policy will remain the same.

15. **Agenda 15: To decide on increasing the remuneration for thesis evaluation, which is @ 1000/- per thesis presently.**

In comparison to the other medical institutes, the thesis remuneration was found to be low and the CoE proposed to increase it. It was resolved to increase the remuneration from current Rs 1000 to Rs 2000.

However, it was advised to seek clarification from NMC that whether prior approval of thesis is still the eligibility criteria for appearing in the MD/MS/DM/MCh examination or thesis has to be evaluated by external examiner from outside the state coming to take clinical/practical examination, as instructed in PGMER 23.

16. Agenda 16: To approve the following rates for entrance/recruitment examinations:

- Rs.100 per MCQ (in single language)
- Rs.150 per MCQ (bilingual)
- Rs. 2000/- for MCQ validation
- Rs. 2000/- for OMR evaluation (manual)

It was approved unanimously.

17. Agenda 17: Proposal to enhance the remuneration of university observer going to affiliated colleges from Rs.3500/- plus GST to Rs.4500/- plus GST along with DA as per conference rules.

After thorough discussion and on proposal of Honorable VC the Finance Officer agreed to increase the remuneration of university observer going to affiliated colleges, from Rs 3500 plus GST to Rs 6000 plus GST but without DA.

18. Agenda 18: To revise the criteria for remuneration of examiners, travelling by road.

It was resolved that the examiners & observers appointed by the university for the affiliated colleges, who travel by road, will get the to and fro taxi fare which should not exceed 17 Rs/Km. Those travelling by own car will get reimbursement according to the government rules.

19. Agenda 19: To implement the rates of OMR scanning / Result Processing for entrance/ recruitment examinations as per the rates approved for university examination.

It was approved unanimously.

Agenda 20: To decide the Fee structure for all the MCQ based Recruitment/ Entrance Exams, that the University conducts on behalf of DGME/ NHM

It was decided that the rates will be same as per university entrance examinations. However, this has to be pre-informed to the DGME and NHM

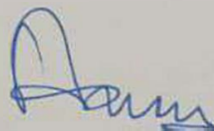

2.5.4: Examination reforms in the process and procedure in the conduct of examination / evaluation for the last 5 years.

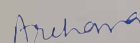

3. The Committee, as directed by the hon'ble Vice-Chancellor, decided that the guidelines of BDS examination pattern as prescribed by the Dental Council of India revised BDS courses Regulations 2007, mentioned in their letter dated 26.07.2017 be strictly followed. iii. In case of non-availability of regular Faculty of the college the matter be referred to MCI for guidance.

5. The DCP Paper I will be on Basic Medical, General Pathology & Microbiology, Paper II will be on Systemic Pathology Cytology and Hematology Paper III shall be MCQ of whole Examination. 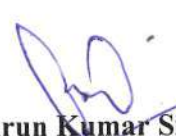

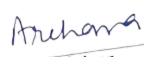

2. The proposed ordinance of Challenged Evaluation received vide letter No.:E-7443/03-GS/2019 (TC) dated 26.11.2020 from Additional Chief Secretary of Hon'ble Chancellor, King George's Medical University was discussed in detail. It was brought to the notice of the Hon'ble members that a reply has already been drafted on the basis of a committee constituted by the former Controller of Examinations, Prof. A.K. Singh. The reply prepared by the committee was communicated to the office of Hon'ble Vice Chancellor vide letter No. 97/Exam./Gen./2020 dated 15.05.2020. After detailed discussions it was unanimously resolved that it shall be ensured that a response on the lines of the recommendations of the committee may be send.
3. The proposal that three sets of question Papers shall be prepared (instead of two), moderated and thereafter picked by lottery system randomly for all University examinations was unanimously approved.
4. The proposal that all theory copies shall evaluated at the central facility located at Pariksha Bhawan at KGMU and at affiliated institutions at their respective administrative blocks was unanimously approved.
5. The proposal that the panel of External Examiners recommended by the board of Studies shall be preferably from institutions of national importance was unanimously approved.
6. The proposal for developing a software for the purpose of online appointment of examiners, setting, moderating and generating question papers, evaluation of answer sheets, tabulation, collation was unanimously approved and it was decided that it shall be implemented in phase wise manner.
7. The proposal of printing of photographs of candidates on mark-sheets along with the identification data and marks obtained by the candidate was unanimously approved.
8. It was unanimously approved that the question papers and answer copies used for various examinations of the University, including that of the entrance examinations conducted by the University shall be disposed of after six months of the declaration of the results. However, if there is any court case or any query with regard to a candidate then that answer copy shall be preserved till the disposal of the case.
9. The proposal to discuss about the policy for the setting of question papers for various Fellowship and PDCC entrance examinations conducted by the University was dropped as a decision regarding the issue has already been taken by the University.

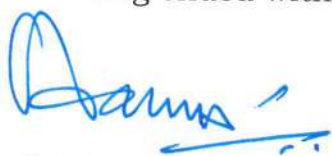
