Tender for supply of Liquid Medical Oxygen

1. Notice Inviting Tender(NIT)

On Behalf of the Hon'ble Vice Chancellor, King George's Medical University UP, Lucknow Tenders are invited in two bid system to supply, installation, commission, operation of Liquid Medical Oxygen vessels & supply of LMO along with conversion of existing compressed medical oxygen manifold system to liquid Medical Oxygen (LMO) system from the exile specialized Original gal Manufactures (OGMS) having experience to the successfully completed similar works during the last three years reckoned backward with reference the the last date of bid submission. It is proposed to install LMO vessels at four locations, the details of proposed LMO vessel locations, user Department and approximate consumption of oxygen are given in Table-1.

Scope of Work:

The vessels of LMO are installed/to be installed at different locations of King George's Medical University UP, Lucknow as mentioned in table-1 the scope of work shall include:-

1. Supply, installation, testing, commissioning of LMO vessels, along with all accessories and obtaining Central Explosives License/other licenses from competent authority for the same and comprehensive maintenance of the same.
2. The space for the installation of LMO vessels and allied activities shall be provided by the University.
3. Supply of LMO and allied activities/services for 5 Years.
4. Conversion of existing centralized compressed Medical (oxygen) Gas pipeline system to Liquid Medical Oxygen system at the Locations mentioned in table-1. The contractor/firm have to connect oxygen manifolds of user departments from LMO vessel through copper pipes of appropriate sizes, free of cost.
5. All associated, supply, construction/ fabrication, maintenance works of mechanical, electrical etc. Shall be done by firm/contractor itself, nothing extra will be paid by the university.
6. Primary civil work will be in the scope of the University.
7. Scope of work shall also include testing, packing, transportation, scheduling of transportation, transit insurance, delivery at sites , filling/loading /unloading, storage job, any other services associated with the supply of liquid medical oxygen , the successful bidder will assume full responsibility of the complete system unit up to existing manifolds of user departments
8. Comprehensive operation and maintenance of the whole system of LMO and accessories up the existing manifolds of user departments as mentioned in table-1
9. The firm/contractor has to quote for Liquid Medical Oxygen (Net Price) Per KG only.
10. The bidders are required to have survey of the proposed sites of king George's Medical University UP, Lucknow before preparation and submission of tenders.

Section II: Qualification/Eligibility Criteria and preparation of Tenders

Tenderers should submit tender in the following two Covers:-

- (A) Prequalification/ technical bid Cover (Cover-1)
- (B) Financial bid cover(cover-2)

(A) Prequalification/ technical bid Cover shall include the following:-

1. Bidder should Have successfully completed similar work in a hospital of 750 beds or more during the last three years reckoned backward with reference to the last date of bid submission. (annexure 11& 12)

2. Bidder should have provide a certificate as per Annexure 11, indicating annual turnover of at least Rs 300 crore or more per year during preceding three consecutive financial years i.e for 2016-17, 2017-18 and 2018-19, duly audited and certified by approved chartered accountant.
3. Original EMD to be submitted along with technical bid in form of FDR and in favorer of finance officer, king George’s Medical University UP, Lucknow.
4. The Contractor should have solvency certificate at least 10 crore from banker.
5. Original copy of Two undertaking on –judicial stamp paper of Rs. 100/-
 - a. For terms & condition of this tender- to be submitted in the format given at Annexure-3.
 - b. For Overall comprehensive operation and Maintenance of LMO system including all accessories up to existing manifolds of user departments- to be submitted in the format given at Annexure-4.
6. The Tenderer should be either a manufacturer of LMO. Certificate to be submitted as per annesure-7.
7. Tender Form as per Annexure-5 on the letter head.
8. Central Sales Tax/state Sales tax (VAT) registration number with attested photocopies of registration certificate.
9. A Copy Sales Tax/Commercial Tax Registration Certificate dully attested by a gazette officer. Should also be enclosed.
10. Trade Tax, Commercial Tax clearance certificate to be submitted along with copy of PAN and acknowledgement for filling latest Income Tax Return.
11. An notarized affidavit on non-Judicial Stamp, that the tenderers has never been convicted by Hon’ble court/competent authority and have not been black listed by any organization must be attached along with the tender failing which the Tender will be rejected.
12. Tenderers should also submit technical literature, brochures and other document in support of suitability of the goods quoted by them.
13. The successful Tenderer selected for supplying Liquid Oxygen has to install the storage tank of required standard having required capacity in premises of university at their own cast and obtain the license from chief controller of explosives. (Competent Authority of India)
14. Valid copy of drug License certificate, issued by competent Authority with date of expiry.
15. Additional information as per Annexure-6
16. Tenderer who does not fulfill any of the above requirement/Technical requirement and/or gives evasive information shall be liable to be ignored and rejected.

17. Tenderer Should furnish a list of successful installation & commission executed by them for similar installation & supply, preferably from Govt. Hospital/institution in India , in the last three years reckoned backward with reference to the last date of bid submission.

(B) Financial Bid Cover(Cover-2)

- 1- Tenderers must survey the sites and asses the all kind of works involved including supply of liquid medical oxygen for a period of five years and quote their prices schedule format (cover-2 financial bid) as give under Annexure-2.
- 2- Tenders must be careful while quoting the rate in price schedule and should read the instructions to supply of liquid gas along with free of cost supply & installation of LMO vessels and all associated works as mentioned in scope of works /tender document. Price to be quoted in Indian rupees only.

Section III: General Instruction to Tenderers(GIT)

1- General Instruction:

- a. The work shall be executed as per latest international standards, as applicable. The additional specifications/ conditions are to be read in conjunction with above. Nothing extra shall be paid on account of additional specifications and conditions, as the same are to be read along with schedule of quantities of work.
- b. The tenderers should in his /her own interest ,visit and survey the site and get familiarize with the site/conditions before tendering.
- c. The tenderers shall bear all cost and expenditure incurred and/ or to be incurred by it in connection with this tender including survey/visit of site/preparation, mailing and submission of its tender and for subsequent processing of the same . King George's Medical University U.P Lucknow will in no case responsible of liable for any such cost, expenditure etc. regardless of the concoct or outcome of the tendering process.
- d. Successful tenderer will be fully responsible for any accident or mishap involving warders engaged by him/ her any claim made on this part will be paid by the successful tenderer. The successful tenderers shall indemnify the University from any claims arising out of accident or mishaps, disability of any nature or death arising out of provisions under law or of any other nature on respect of all works engaged by successful tenderer.
- e. The language for all kind of document/ communications will be English or Hindi.

2.2 The relevant detail of the required installations & supply of liquid oxygen ,terms & conditions and Procedure for tendering, evaluation, issue of contract, standard formats used for this purpose etc. are incorporated in the above said document. Tenderers should read and examine all these terms & Conditions before preparation and submission of their tenders.

3. Amendments to the tender documents: the Hon'ble Vice-chancellor King George's Medical University U.P Lucknow, at any time prior to the deadline for submission of tender may, for any reason deemed to be unfit by any reason, modify the tender documents by issuing amendments.

4. Tender currencies: the price should be quoted in Indian rupees only Price+Tax or GST, levies and duties wherever applicable in price schedule, nothing will be paid extra.

5. Tender prices: Tenderers should quote their prices in the price schedule format(Cover 2- Financial bid) as given under Annexure-2.

6. Earnest money deposit (EMD in Indian Rupees Only-refundable)

6.1 Tenderer should submit original EMD of Rs. 8,00,000.00(Eight Lakhs) along with Technical Bid.

6.2 EMD should be furnished in the form of FDR from any Indian nationalized bank. EMD should be prepared in Favor of "**Finance officer, King George's Medical University U.P Lucknow 226003.**

6.3 EMD Should be Valid for a period of six months from the date opening of tenders. No interest shall be given on the Earnest Money Deposit.

- 6.4 EMD of unsuccessful tender will be returned after issue of notification of award of contract.
- 6.5 EMD will be forfeited in case the Tender withdraws its tender within the period of validity of Tender.
- 6.6 EMD will be forfeited in case the successful tender fails to furnish the required performance security as per tender document.

7. Validity of Tenders

- 7.1** the Tender will remain valid for 6 months from the date of opening(due date) of tenders.
- 7.2** The vice-chancellor King George's Medical University U.P Lucknow 226003, reserves the right to extend the Validity of tender beyond six months, if desired.

8. Opening of Bids

- 8.1 Authorized representative of the tenderer, who have submitted tender in time, may attend the tender opening process, provided they bring authority letter from the concerned tenderers.
- 8.2 Pre-qualification/technical bids are opened first. These bids shall be scrutinized and evaluated by the competent committee/ Authority.
- 8.3 there after, financial bids of the technically acceptable offers shall be opened for further scrutiny and evaluation. Other Financial bids will not be opened.

9. Award of Contract

King George's Medical University U.P Lucknow, reserves the right to accept or reject any tender without assigning any reason or to cancel the tendering process and reject all or some parts of tenders at any time prior to award without incurring any liability whatsoever to the affected tenderer.

Award criteria

King George's Medical University U.P Lucknow, will notify the successful tenders that its tender for installation& supply of Liquid Oxygen has been accepted.

The Successful tenderer must furnish the performance security 25.00 (Twenty Five Lakh) within 15 days from the date of notification of award as per section-iv.

Non-receipt of performance security

Failure of the successful tenderer in providing performance security within 15 days of receipt of notification of award shall make the tender liable for forfeited of its LMO.

PAYMENT AND ESCALATION OF PRICES:-

Payment for the supply of liquid oxygen shall be made to the successful bidder within 45 days of presentation of bills/invoice in duplicate. Bill/invoice shall be certified by Electrical/mechanical Engineering Department.

TERMINATION OF AGREEMENT:-

1. After giving opportunity of being heard of the successful tenderer, the University may terminate/cancel the agreement on the following grounds.
 - A. Breach of any or all terms and condition/Instruction/clauses of Agreement.
 - B. Non- performance or unsatisfactory Performance of work.
 - C. Documents or information furnished with tender is found forged or fabricated.
2. Not with standing to any provision of the agreement, if the agreement is terminated by the university and the hospital has to award the work to other party on higher rate, the successful tenderer has to compensate the difference of cost for entire remaining period of Agreement to the university.

Section IV: General conditions of Contract(GCC)

1. Tender document may be downloaded from our University website www.kgmcindia.edu. But the tender fee Rs. 5000.00+GST in form of D.D drawn on any scheduled bank, in favour of finance officer K.G.M.U U.P Lucknow payable at Lucknow will necessarily to be attached with technical bid otherwise tender will be rejected. This amount will be non refundable.
2. Validity of Tender: it should be valid up to six months from the date of opening of Tender.
3. The period of completion of works six months.
4. The tender has to quote for Liquid Oxygen(net. Price) Per Kg. the quantity of net weight(in kg) will be converted into Cu M with the following formula.
$$01 \text{ kg} \times 0.77 = \text{CuM}$$
5. Successful tenderer has to supply the desired quantity of liquid oxygen as per the schedule which would be mentioned in the written order or may be intimated verbally through Telephone from into time as per our actual requirement.
6. Liquid oxygen will be supplied by the successful Tenderer depending upon day to day demand of University.
7. The Tenderer should have minimum audited annual turnover of 200 crore.
8. The successful Tenderer having supply order of Liquid oxygen shall make sure the availability of liquid oxygen to supply it through center pipe line system without any interruption any failure shall be the responsibility of the successful tenderer. The successful tenderer should also make sure the availability of 'D' type filled oxygen cylinder in adequate number, so that in case of crisis central supply of oxygen can maintained till the liquid oxygen is supplied by successful Tenderer. The payment oxygen gas supplied through cylinders will be made on the same rate as of liquid oxygen.
9. The successful tenderer should give an undertaking to be always maintained the supply in large quantities of liquid Oxygen in case of emergencies e.g mass casualty, epidemics etc. even during odd hours.

10. Each and every supply may be delivered between office hours only Monday to Friday 09:30 am to 05:00 Pm on Saturday 09:30 am to 01:00 Pm. In case of delayed supply or extra emergency demand, supply will be received with the consent of institute authorities.
11. The successful Tenderer should have or open a current/saving bank account with any nationalization bank in lucknow with in a week time and intimate the no. to the finance Department. Nodal Department and contract cell of the University.
12. In case the Successful Tenderer fails in fulfilling the obligation fully and in time, the University shall have the absolute right to take up the work at the successful tenderer's cost risk and recover all such expenses from the amounts due to the Successful Tenderer including their security deposit.
13. All letters posted to the successful tenderer on the address given by him will be considered to have been delivered to him in time.
14. If it is observed at any stage that the supply of Liquid medical Oxygen is not satisfactory. The contract may be terminated and the security deposit may also be forfeited. The successful tenderer will have no claims what so ever on the university.
15. The successful Tenderer shall be liable to pay compensation for any loss and damage caused to the property of the university or the patient by successful Tenderer or his workers.
16. While quoting the rate the tenderer should certify that they have valid license for Mfg./Testing of the product of the particular items vide Drug License no----- date-----which should be valid on the date of opening of tender.
17. Installation of the LIQUID MEDICAL OXYGEN TANK and filling of the LIQUID OXYGEN shall be done by successful tenderer.
18. The successful tenderer would be responsible for the yearly testing of the tank and will provide certificate of the same to the university.
19. Successful tenderer will provide calibration chart of the tank i.e. gage indicating water level inches equivalent to cubic meters the same should be market on the tank also.
20. Successful tenderer would be responsible for the panting of the tank every year.
21. The Successful tenderer will ensure the exact quantity of LIQUID OXYGEN being supplied by proper measurement/calibration of the tanker, which shall be arranged by him falling which the supply will be replaced by the successful tenderer at his own cost.
22. The successful tenderer would have to supply liquid oxygen in his Own tanker.
23. LIQUID OXYGEN will only be received after being gross weight of the tanker at dharma kanta (nearest of University) along with the receipt. The tanker will be sent again to the same dharma kanta on the same day after filling tank situated to obtain

- the tare weight and net weight of the LIQUID MEDICAL OXYGEN supplied to the Institute.
24. Respective person from the institute will visit the dharma kanta from time to time for inspection of the gross weight, tare weight and net weight of the LIQUID OXYGEN TANKER successful Tenderer will provide necessary cooperation in matter.
 25. The Tender will have to be submitted for each part separately in two separate covers one of which shall contain the Technical requirement bid and shall be opened first. Only upon approval by the committee, the Financial bid shall be Opened for the final decision and possible negotiations.
 26. The contractor/tenderer must comply with all relevant applicable standards/codes/acts/rules.
 27. All Medical gas pipeline works will be done as per NFPA/HTM/BIS/BS Specification (as applicable).
 28. Rates should be inclusive of all kind of taxes, nothing will be paid extra (BOQ attached).
 29. All required civil, electrical and mechanical works related to operation, installation, commissioning, Maintenance of work as mentioned in the scope of work/tender document, shall be done free of cost by agency/contractor, nothing extra will be paid for it.
 30. The taxes will be deducted by the university as per rule.
 31. The contractor/agency shall complete the work within given time frame from the date of issue of the work order, if contractor fails to do so, appropriate penalty will be imposed as per the University.
 32. The contractor/agency shall repair/maintain all defects of the existing structure/system/building etc., occurred due to installation/commissioning of works.
 33. The contractor/agency shall Provide warranty against any designing/manufacturing/installation/commissioning defects for a period of 5 years from the date of complete.
 34. The number and sizes of LMO vessels are tentative/approximate, the agency/contractor are required to assess/design/proportionate the whole system of LMO depending on the requirements of different department to be connected.
 35. The contractor should have a minimum average annual turnover of 200 crore for last three financial Years and never incurred any loss in the balance sheet of last three year ending 31st March 2020.
 36. The bidder should have a directly/indirectly one work order of supply of Liquid Medical Oxygen and installation of LMO vessel in minimum 750 bedded government Hospital Govt./semi Govt. Hospital.
 37. The Contractor should have solvency certificate of at least 01 crore from banker.

38. This contact is subjected to the Jurisdiction of Lucknow Court only.
39. In case of any dispute including quality and performance the decision of the vice-chancellor K.G, Medical University U.P Lucknow shall be final and binding on Both parties.
40. The University will have the right to reject/cancel all or any of the tender without assigning any reason.
41. In case the successful Tenderer fails to supply the gas by the date of supply Order, University will levy a penalty as under.
 - a- After 24 Hours up to 48 hours @ 1% of the value of the actual supply.
 - b- After 48 Hours @ 2% per day up to 10% of the value of the actual supply.
42. The delivery of the goods shall have been deemed to taken place on delivery of the goods in accordance with the terms of the contract, after approval by the inspecting officer if so provided in the Contract.
43. Executive Engineer(E/M) reserves the right to select different or same vendors for LMO. However, selection of vendor/ranking will be done on the basis of Net rate(which are inclusive of all installation, rental, transportation, testing, Maintenance etc. Charges) of Liquid medical oxygen only.
44. Minimum 40% of stock level to be maintained in the installed capacity to avoid emergency situation & for the same supplier should install suitable monitoring & alarming devices.

SECURITY DEPOSIT:-

25 Lakh Security Money shall be deposited by the successful tenderer in the form of bank Guarantee/FDR of any nationalized bank in favour of Finance officer King George's Medical University U.P Lucknow for a period- of 66 months with in 15(fifteen) days from the date of award of bid by the university. The university shall be entitled to claim. adjust any due amount from the said security deposit.


